G) AUTHORISATION AND DECLARATION

- I have read and understood all the pages of this Application form and agree to the Terms & Conditions of this investment into the ETF Tax Free Investment Account.
- 2. I understand that this Application and any other further documents read with the Application constitute the entire Application between the Administrator and myself.
- 3. I warrant that the information contained herein is true and correct and that when this Application form is signed in a representative capacity, I have the necessary authority to do so and that the transaction is within my power.
- The maximum investment in the ETF Tax Free Investment Account is R33 000 per individual in any one tax year and R500 000 4. over the life of an individual, or as amended by law from time to time.
 - Over time, the balance in the Tax Free Investment Account may exceed the R500 000 limit, due to accumulated earnings and capital gains.
- I acknowledge that the Administrator cannot accept contribution amounts in excess of these amounts and lifetime limits. I also acknowledge my responsibility to ensure that I adhere to these annual amounts or lifetime limits, or else face penalties for breaching these limits.
- I accept that withdrawals can be made from the Tax Free Investment Account at any time, but such accumulated savings cannot be replaced.
- I accept that investments are traded on a weekly basis in an effort to reduce costs. The Administrator will apply interest to my cash funds in return for any prejudice that might occur due to market movement.
- I understand and agree that no part of the services provided by the Administrator and portfolio manager constitute a solicitation, recommendation, guidance or proposal, nor does it constitute financial, tax, legal, investment nor any other advice. I warrant to

the Administrator and to the portfolio manager that I am acting for my own account, I have made my own independent decisions to enter into this investment, as to whether the investment is appropriate or proper for me, based on my own judgement, or upon advice from such advisors I deem necessary.

- 9. I further warrant that the information and expectations relating to the terms and conditions of the investment shall not be considered as investment advice, or a recommendation to enter into the investment. I have not received from the Administrator or the portfolio manager any assurance or guarantee as to the expected result of the investment.
- 10. I authorise the portfolio manager to enter into transactions on my behalf and to make investments in my portfolio under a Tax Free Investment Account. The portfolio manager may amend the composition of the investment portfolio from time to time. I further consent to the appointment of Computershare (Pty) Ltd as the custodian and Administrator on behalf of the portfolio manager and my Tax Free Investment Account.
- 11. I authorise the Administrator to accept and act on my instructions by facsimile or email and hereby waive any claim I have against the Administrator and indemnify the Administrator against any loss incurred as a result of the Administrator receiving and acting on such communication or instruction.
- 12. Any personal information may be used by the Administrator and the portfolio manager in the normal course of business to provide the services related to the Tax Free Investment Account and they may retain this information for purposes of investment transactions, processing and administration and to communicate directly with me. Personal information will not be given or sold to any third parties. The Administrator and/or the portfolio manager will disclose or report personal information if and when required to do so by law or any regulatory authority.
- 13. I consent to the Administrator making enquiries of whatsoever nature for the purposes of verifying the information I have disclosed on this Application, to prevent and detect fraud, and I express my consent to the Administrator obtaining any other information concerning me from any source to enable the Administrator to process this Application.
- 14. I confirm that I am not acting in the capacity of a nominee intending to hold Securities on behalf of a beneficial owner. (Please note that nominee companies must be approved by the Financial Services Board before an investment account may be opened. The ETF Tax Free Investment Account is only available to private individual investors and not to institutional investors or nominees).
- 15. I agree that all ETFs purchased through the Tax Free Investment Account will be registered in the Investor's name under Computershare Nominees (Pty) Ltd on the Strate securities register. I elect not to open a Segregated Depository Account. Should I decide to open such an account at a later stage, I will advise the Administrator.
- 16. I elect not to receive distribution announcements and note that all distributions that accrue on the Tax Free Investment Account will automatically be reinvested.
- 17. I agree that all income that accrues on my investment will only be paid to me once the Tax Free Investment Account has been opened.
- 18. I agree that if I elect the Debit Order option (Section E), although the authority may be cancelled by me, such cancellation will not cancel this Application. I shall not be entitled to any refund of amounts which the Administrator has withdrawn while this authority was in force, if such amounts were legally owing to the Administrator.
- 19. I acknowledge that this Authority may be ceded or assigned to a third party if the Agreement is also ceded or assigned to that third party, but in the absence of such assignment of the Agreement, this Authority and Mandate cannot be assigned to any third party.
- 20. I consent to the Administrator providing data, statements, or any other related documentation relating to my Tax Free Investment Account, to the Portfolio Manager.
