b. Landing page

Once you are logged in your SAP shares account, you can view the following landing page.

- 1. Certify your tax residency status... > This will sign you into the Identity self-certification system ¹

- 4. View your documents > View your personal correspondence, such as grant letters.

1 The online facility 'Identity' is a service which is licenced to Computershare by an external provider – Thomson Reuters, who also ensure that any changes or legal updates are constantly reviewed and applied. This means the information held on your behalf, once completed, remains valid. If for any reason you are required to amend your information, you will be contacted at the appropriate time.

It is however the responsibility of the participant to maintain their tax residency by self-certifying on the Identity system as and when this changes or requires adjustment.

2 The German Tax Exemption Form will only appear once you have completed your Identity certification and certified as a German taxpayer (providing your date of birth and your Identifikationsnummer (not the old Steuernummer)). The Exemption form will not be available until 1 UK business day after your identity certification has been submitted.
